Whereas vide this office order No: 161-SHDJ of 2019 dated 17-06-2019 duly endorsed vide No: DSHJ/Esstt-NG/F-103/2019-20/3714-27 dated 17-06-2019, three posts of Stock Assistants were allotted to you for filling up of the same under 40% promotion quota


Whereas vide this office letter No: DSHJ/Esstt-NG/F-85/2019-20/927-38 dated 22-11-2019 followed by reminder vide No: DSHJ/Esstt-NG/F-85/2019-20/2489-2500 dated 28-12-2019 all the District Sheep Husbandry Officers including you were directed to submit the documents of eligible officials for seeking approval from this office but no response has been received from your side.

Whereas vide this office order No: DSHJ/Esstt-NG/F-33/2019-20/7694-7701 dated 18-03-2020, the respective District Sheep Husbandry Officers including you were directed to submit all relevant related documents of eligible Assistant Stockman within week's time positively for seeking approval to avoid hue and cry from any corner.

Whereas you have submitted a letter bearing No: DSHOD/2020-21/309-10 dated 04-05-2020 through e-mail to Joint Director (Extension), Sheep Husbandry Department, Jammu who in turn endorsed the same to this office for further necessary action vide endorsement No: JDEJ/Esstt/2020-21/104 dated 09-05-2020.

Whereas in response to above, you were directed to submit original documents from serial No. 01 to 06 including affidavits from the concerned eligible employees duly attested by the Executive/Judicial Magistrate 1st Class while taking into consideration the instructions conveyed by the Department of Justice, Law & Parliamentary Affairs and General Administration Department vide this office letter No: DSHJ/Esstt-NG/F-33/2020-21/1991-92 dated 18-05-2020.

Whereas original letter No: DSHOD/Esstt/2020-21/309-10 dated 04-05-2020 received by the Joint Director (Extension), Sheep Husbandry Department, Jammu and he had endorsed the same to this office vide endorsement No: JDEJ/Estt/2020-21/157 dated 20-05-2020. While perusing the same, it has been found that you have recommended three employees for promotion against roster point No: 12-OM, 13-OM and 14- RBA in terms of SRO 144 dated 28-05-2008. It is highly regretted that you did not bothered to go through the contents of the communications as conveyed by the Department of Justice Law and Parliamentary Affairs J&K bearing O.M. No: LD (Lit)




2017/09-SC/Agri dated 11-05-2016 and General Administration Department's O.M. No: GAD/MTG/RB-IV/04/2016 dated 21-06-2016.

Whereas it seems that you have been deliberately causing delay in recommending the eligible officials as per the rules in vogue, despite of sufficient correspondence resting with you.

Keeping in view of the above you are finally directed to recommend only eligible candidates as per roster for promotion by enclosing the following testimonials in original **within three days positively**; other-wise you shall personally held responsible for the consequences.

- Roster point register in original against which the eligible officials are to be promoted alongwith the previous detail by entering the name of eligible officials recommended for promotion
- To furnish a certificate in respect of each eligible official regarding status of criminal/court case against them in Hon'ble High Court/District Court as well as in Vigilance organization.
- Undertaking in shape of affidavit from the concerned eligible officials duly attested by the Executive/Judicial Magistrate 1st Class stating therein that no Criminal matter/ vigilance case against them is pending in any court/ Anti corruption Bureau in Union Territory of Jammu and Kashmir.
