
**Government Order No: 498 - JK (APD) of 2023

In super-session of all previous orders on the subject and pursuant to provisions of SRO-43 dated 17.02.2004, a committee of following officers is constituted to consider Time Bound Promotion of Gazetted Officers in Animal/Sheep Husbandry Department.

1.	Administrative Secretary/Secretary in the Department, Animal/Sheep Husbandry Department	Chairman
2.	Directors, Concerned.	Member
3.	Director, Finance, Animal/Sheep Husbandry Department.	Convenor
4.	Representative of Administrative Department not below the rank of Deputy Secretary.	Member
5.	Law officer/Legal Assistant concerned.	Member

The committee shall, inter-alia, consider following criteria for clearance of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Time Bound Promotion cases:-

- i. Scrutiny of APRs for last 05 years.
- ii. Vigilance Clearance.
- iii. Integrity certificate to be certified by the concerned HOD(s).
- iv. Departmental enquiry status of the officer(s).
- v. Whether any officer has been suspended/charge sheeted/cases challenged in the court of law.
- vi. Details of complaints pending against the officer(s) and their status.
- vii. Performance of the officer(s).

- viii. Whether officer(s) has complied with orders issued by the Government/Directors from time to time in the interest of Administration.
- ix. Any other issue which the committee may consider necessary.

The committee shall adhere to all other provisions of SRO-43 and those directions/orders as may be issued by the Government from time to time.

The committee shall meet at least twice in a year and preferably in the months of January and July.

The concerned Heads of the Department shall submit the proposal, complete in all respects, to the Administrative Department at least one month before holding of the meeting.
