**ORDER NO. 65 - SHDJ OF 2022

In terms of Jammu & Kashmir (Compassionate Appointment) Rules 1994 notified vide SRO-43 of 1994 dated 22.02.1994, sanction is hereby accorded to the temporary appointment of Ms. Asma Talat D/O Late Talat Mehmood Mir (Deceased Flock Supervisor) R/O Village Krawah Tehsil Banihal District Ramban, as Assistant Stockman in the Pay Level-SL1 (14800-47100) in pursuance to S.O. 151 dated 04.04.2022, in District Cadre Ramban after receipt of satisfactory verification report from Criminal Investigation Department J&K vide letter quoted under reference.


The appointee shall report to the District Sheep Husbandry Officer, Ramban within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently: -

1. Academic Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Dependent Certificate issued by the concerned Competent Authority.
5. Character Certificate.
6. Certificate from the General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken.
7. Domicile Certificate issued by the concerned competent authority.
8. All other relevant documents as are required under SRO-43 of 1994 and other rules in vogue.

The appointment of the appointee, shall further be subject to the following conditions: -

- a. That the appointee shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate 1st Class to the effect that if on verification, genuineness of the qualification and date of birth certificates produced by the appointee are found





fake/forged, the appointment of the appointee shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against the applicant.

- b. The salary of the appointee shall not be drawn and disbursed to the applicant unless satisfactory reports in respect of (a) above is received from the concerned Competent Authorities.
- c. The appointment of the candidate shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O No. 192 of 2020 dated 17.06.2020.
- d. The appointment of the candidate shall also be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, his appointment shall be deemed to have been cancelled ab-initio without any further notice as per the Circular No. 08-JK(GAD) of 2019 dated 04.12.2009.

District Sheep Husbandry Officer, Ramban will issue adjustment order in favour of the appointee against the available vacant post of Assistant Stockman in the District.

This issues without prejudice to the outcome of writ petition(s) pending, if any, before any competent court of law and shall be subject to the outcome of such writ petition(s).
