Subject: Grant of Higher Standard Pay Scale in favour of Members of Jammu & Kashmir Sheep Husbandry (Subordinate) Service.

Reference: Minutes of Meeting of the Departmental Promotion Committee held on 29.12.2023.

ORDER NO. 190 - SHDJ of 2024

DATED 18-03-2024

In continuation to this Directorate's Order No. 31-SHDJ of 2024 dated 22.01.2024 and as recommended by the Departmental Promotion Committee in its meeting held on 29.12.2023 constituted vide Order No. 420-SHDJ of 2023 dated 26.08.2023 and in terms of SRO-14 dated 15.01.1996 read with amendments and clarifications thereto, issued by the Finance Department J&K from time to time, sanction is hereby accorded to the grant of Higher Standard Pay Scale in favour of 02 Members of Jammu & Kashmir Sheep Husbandry (Subordinate) Service listed in Annexure to this Order, from the date(s) indicated against each.

This however shall be subject to the following terms and conditions as laid down in the aforesaid SRO to be examined by the concerned Drawing and Disbursing Officer: -

1. That the employee availing the benefit shall give an undertaking to the Drawing and Disbursing Officer to the effect that as and when he/she will be eligible for functional promotion, he/she will not refuse.
 2. That no higher standard pay scale shall be allowed to the employees who are under suspension on the date of eligibility or who is charge-sheeted under the provisions of The Jammu & Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 or any other rules for the purpose.
 3. That such period of leave without allowance as had not been agreed to by the competent authority to be counted for purpose of annual increments shall not be taken in to account for rendering of the period of 9/18/27 years for higher standard pay scales as the case may be.
- That the work and conduct of the concerned eligible employees has remained satisfactory as per APR's together with result for preceding three years.

5. That if there is any case against the official included in the sanction order pending in the department/Vigilance Department/Court of Law or who are involved in misappropriation, misconduct, embezzlement/corruption, retention of Govt. money, the in-situ promotion granted in such case should not be implemented and his/her case be referred to this Directorate for cancellation for his/her In-situ promotion immediately.
6. That the benefit of promotion shall not be given to such employees who relinquishes/relinquished promotion for reasons whatsoever.
7. That the Drawing & Disbursing Officer shall only allow the benefit of In-Situ promotion to those persons, who had not availed the benefit of three promotions including functional promotion, if any, granted during the entire period of their services.
8. The benefit of In-situ promotion shall be subject to further verification from the original record by the concerned Drawing & Disbursing Officer.
