



**Subject:- Authorization for purchase of Foot and Mouth Disease Vaccine.**

Reports were received from different channels regarding spread of Food and Mouth Disease among the migratory livestock (Sheep/Goat) which has migrated to valley and other upper reaches of Division. The matter for Supply of FMD Vaccine was taken up with Chief Executive Officer, Livestock Development Board, Jammu but Chief Executive Officer, Livestock Development Board, Jammu vide his communication No: CEO/LDBJ/2021-22/314-15 dated 31-05-2021 has intimated that FMD vaccine is not available with the Board at present. The fact was also communicated by Director, Sheep Husbandry Department, Kashmir regarding outbreak of FMD in the migratory flocks of breeders of Jammu Division which has migrated to the upper reaches of Kashmir Division vide his office letter No:-DSHK/Tech/2021-22/Migration/FMD/2877-79 Dated:- 14-06-2021. Keeping in view the exigency of the matter, the below mentioned Drawing and Disbursing officers are authorized to purchase Foot and Mouth Disease vaccine from approved firms after observing all codal formalities as required under rules.
