**ORDER NO. 126-SHDJ OF 2022

Whereas, Mr. Umesh Kumar, Assistant Stockman of District Kathua was arrested by Kathua police on 07.05.2021 in FIR No. 209/2021 u/s 8/20/29 NDPS Act and accordingly placed under suspension w.e.f 07.05.2021 by the District Sheep Husbandry Officer, Kathua vide Office Order No. DSHOK/Esstt/2021-22/255-60 dated 11.05.2021; and

Whereas, he was granted bail by the Hon'ble Court Kathua on 19.05.2021 and released from the police custody on bail and joined in the office of District Sheep Husbandry Officer Kathua on 22.05.2021; and

Whereas, District Sheep Husbandry Officer, Kathua vide Office Order No. DSHOK/Esstt/2021-22/329-33 dated 22.05.2021 attached the official in the office of Veterinary Assistant Surgeon ISD Block Kathua till outcome of the final decision from the Hon'ble Court; and

Whereas, this Directorate vide communication No. DSHJ/Esstt-NG/F-03/2021-22/3352-53 dated 25.05.2021 approved the action taken by the District Sheep Husbandry Officer, Kathua; and

Whereas, this Directorate vide Order No. 206-SHDJ of 2021 dated 02.12.2021 released subsistence allowance @ 50% in favour of Mr. Umesh Kumar, ASM; and

Whereas, District Sheep Husbandry Officer, Kathua vide communication No. DSHOK/Estt/2021-22/2271-72 dated 26.02.2022 intimated this Directorate that Hon'ble Session Court, Kathua vide order dated 14.02.2022 has discharged Mr. Umesh Kumar, ASM from commission of offences u/s 8/20/29 NDPS Act and requested to reinstate him; and

Whereas, this Directorate vide communication No. DSHJ-ESTT0NG/33/2021/21173 dated 30.03.2022 directed District Sheep Husbandry Officer Kathua to seek a report from the Prosecution Wing of Jammu & Kashmir Police of District Kathua that no further appeal in the case is preferred; and

Whereas, Senior Prosecuting Officer DPO Kathua vide communication No. Pros/Appeal/960 dated 19.05.2022 addressed to District Sheep Husbandry Officer, Kathua has informed that no appeal has been

preferred/filed in case FIR No. 209/2021 offence u/s 8/20/29 NDPS Act P/S Kathua against judgment dated 14.02.2022 passed by the Hon'ble Session Court Kathua; and

Whereas, District Sheep Husbandry Officer, Kathua vide communication No. DSHOK/Estt/2022-23/612-13 dated 20.05.2022 requested this Directorate to reinstate Mr. Umesh Kumar in light of Hon'ble Session Court, Kathua's judgment dated 14.02.2022 and Senior Prosecuting Officer Kathua's communication dated 19.05.2022.

In view of the above, Mr. Umesh Kumar, Assistant Stockman (multi tasking staff) of the organization of District Sheep Husbandry Officer, Kathua presently attached in the office of Veterinary Assistant Surgeon ISD Block Kathua is hereby reinstated with immediate effect and is directed to report at his original place of posting.

The period of suspension shall be settled by the District Sheep Husbandry Officer, Kathua as per norms.
