

Sanction is hereby accorded to the release of funds to the tune of **Rs. 88.80 lacs** (Rupees Eighty Eight Lacs and Eighty thousands only) under the Scheme "0896 Infrastructure for the Welfare of Tribals" for Establishment of Mini Sheep/ Goat units under Tribal Sub Plan and placement of the same at the disposal of concerned DDO's for its utilization during the current financial year 2023-24 as per details given as Annexure "A"

The funds shall be utilized subject to the following conditions: -

- 1. The funds released shall be utilized only for the purpose specified after observing all pre-requisite codal formalities/procedures under rule and shall not be available for further re-appropriation / diversion at any level and for any reason what so ever.
- 2. The animals purchased / retrieved under the scheme shall be branded immediately as per the guidelines issued vide this office letter No. DSHJ/Tech/2023-24/6125-48 Dated 04.07.2023 and the list of the same shall be submitted to this office before distributing to the breeders.
- 3. The Animals purchased shall be free from any physical abnormalities and wool samples for the same shall be got tested from Fleece Testing Laboratory for various parameters.
- 4. The procurement plans from conceiving the nature and quantity of public goods and services to be procured for preparation of tenders/ RFQs /EOIs to final award of the contract by the department shall be limited by an outermost cap of 60 days. Any spill over in timeline shall be allowed only under orders of the competent authority with cogent reasons.
- 5. Treasury Officers concerned shall ensure that releases have been made by DDO's via BEAMS and shall also be personally liable for making any payment not authorized and accepted on BEAMS application.
- 6. The Controlling Officer/ District Sectoral officer shall be personally responsible for any liability created on account of un-authorised/un-approved works.
- 7. The concerned DDO's shall ensure uniform pace of expenditure during the financial year and shall accordingly plan their expenditure from the beginning to avoid rush of expenditure at the fag end of the Financial Year.
- 8. There shall be no expenditure on Revenue or Revenue like components out of UT Capex Budget.
- 9. Photographs and outcome details shall be uploaded on UT Portal of Tribal Affairs Department and AHIGRAMS Portal of Govt. of India.
- 10. Monthly Physical and Financial Progress Report and cumulative expenditure and physical achievements (component-wise) of the funds so released shall be submitted to this Directorate by or before 2nd of each successive month as per the following format.
