The funds shall be utilized subject to the following conditions: -

- 1. The funds released shall be utilized only for the purpose specified after observing all prerequisite codal formalities/procedures under rule and shall not be available for further reappropriation / diversion at any level and for any reason whatsoever.
- 2. The procurement plans from conceiving the nature and quantity of public goods and services to be procured for preparation of tenders/ RFQs /EOIs to final award of the contract by the department shall be limited by an outermost cap of 60 days. Any spill over in timeline shall be allowed only under orders of the competent authority with cogent reasons.
- 3. The Project/ scheme shall be executed and completed strictly within the timeline as stipulated in the tendered document and fixed by the Competent Authority.
- 4. Treasury Officers concerned shall ensure that releases have been made by DDO's via BEAMS and shall also be personally liable for making any payment not authorized and accepted on BEAMS application.
- 5. The Controlling Officer/ District Sectoral officer shall be personally responsible for any liability created on account of un-authorised/un-approved works.
- 6. The concerned DDOs while referring bills to Treasuries shall invariably ensure Photographic evidence of all works (pre execution, during execution & post execution) alongwith latitude-longitude co-ordinates of the project location for its uploading into the system being devised for the purpose.
- 7. The concerned DDOs shall ensure uniform pace of expenditure during the financial year and shall



accordingly plan their expenditure from the beginning to avoid rush of expenditure at the fag end of the Financial Year. 8.

There shall be no expenditure on Revenue or Revenue like components out of UT Capex Budget.
