In terms of Jammu & Kashmir (Compassionate Appointment) Rules, 1994 notified vide SRO-43 dated 22.02.1994 read with Rule 18 of Jammu and Kashmir Rehabilitation Assistance Scheme, 2022 issued vide S.O. 429 dated 06.09.2022, sanction is hereby accorded to the temporary appointment of Ms. Monica Devi W/O Late Ranjeet Singh (Ex-Assistant Stockman) R/O Village Poneja P.O Nai (Bhallara) Tehsil Chiralla District Doda, as Multitasking Staff (Assistant Stockman) in the Pay Level-SL1 (14800-47100) in District Cadre Doda against clear vacancy, in relaxation of the qualification bar in terms of of Rule-7 of SRO-43 of 1994.

The appointee shall report to the District Sheep Husbandry Officer, Doda within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates, in original, to be verified subsequently: -

1. Academic Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Dependent Certificate issued by the concerned Competent Authority.
5. Character Certificate.
6. Domicile Certificate issued by the concerned competent authority.
7. All other relevant documents as are required under SRO-43 of 1994 and other rules in vogue.

The appointment of the appointee, shall further be subject to the following conditions: -

- a. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Center (DIC) and District Employment & Counseling Center of the domicile District, she shall relinquish the proprietorship of unit/enterprises and also stakes, if any, in such self employment unit/enterprise before joining the Government service. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recover.
- b. That the appointee shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate 1<sup>st</sup> Class to the effect that if on verification, genuineness of the qualification and date of birth certificates produced by the appointee are found fake/forged, the appointment of the appointee shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against the applicant.
- c. The salary of the appointee shall not be drawn and disbursed to her unless satisfactory reports in respect of (a) & (b) above are received from the concerned Competent Authorities.
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, she shall forego his right of appointment, which shall be deemed to have been cancelled ab-initio without any further notice, as per the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019.

This issues without prejudice to the outcome of writ petition(s) pending, if any, before any competent court of law and shall be subject to the outcome of such writ petition(s).
