**Subject: Completion of period of Probation of Gazetted/Non-Gazetted/Class-IV staff of Sheep Husbandry Department Jammu Division.**


**CIRCULAR**

In terms of Rule 22(1)(a) of Jammu & Kashmir Civil Services (Classification, Control & Appeal) Rules, 1956 and SRO-202 dated 30.06.2015 read with S.O 194 dated 17.06.2020 and amendments thereto issued by the Govt. from time to time, the appointing authority if considers the probationer suitable for confirmation at the end of the prescribed period of probation, it shall as soon as possible issue order declaring the probationer to have satisfactorily completed his period of probation or else the appointing authority may extend the period of probation of a probationer for another two years, if the probationer fails to meet the standards of the job.

Accordingly, it is enjoined upon all the Drawing and Disbursing Officers working under the ambit of this Directorate to submit the cases of eligible officers/officials working under their control through proper channel to this office who are appointed under SRO-202 dated 30.06.2015 and have satisfactorily completed their probation period of 02 years with the following requisite documents for further necessary action: -

1. APRs in original in respect of Gazetted & Non-Gazetted Staff for last two years duly accepted by the Competent Authority.
2. Work & Conduct Certificate.
3. Undertaking in terms of GAD's OM No. GAD/Mtg/RB-IV/23/2020 dated 31.07.2020 to the extent that the candidate agrees to the terms and conditions provided in S.O 194 dated 17.06.2020.
4. Photocopy of Service Book duly attested by the DDO.

DDO's are advised to process only those cases of officers/officials which fulfill all the necessary criteria as laid down under rules.
