Subject: Filing of Annual Property Returns by the Public Servants (Members of Jammu & Kashmir Sheep Husbandry Subordinate Service) for the year 2021 through Online Property Returns System (PRS Portal).

CIRCULAR


Government of Jammu & Kashmir has issued a Circular vide No. 56-JK(GAD) of 2021 dated 22.12.2021 which was endorsed by this Directorate among all DDO's under endorsement No. DSHJ-ESTT0GAZ/38/2021/16689-721 dated 27.12.2021 whereunder it has been made mandatory for all Public Servants to file their annual property returns on the PRS Portal (<https://prs.jk.gov.in>) launched by the Government. The filing of annual property returns on the portal has started with effect from 1st of January, 2022 and the facility will get automatically closed on 31st of January, every year.

For submitting the details on the portal, every employee has to first register himself/herself on the portal through his CPIS account. In case of employees with no CPIS number, their respective DDOs shall get them registered on the portal. The portal will also facilitate processing of vigilance clearance in favour of the employees and non-submission of the property returns will result in denial of their vigilance clearance.

Director, Anti-Corruption Bureau J&K vide Circular bearing No. ACB/PRS/2022/274-76 dated 06.01.2022 has also directed this Directorate to inform all employees to file their annual property returns through PRS portal only and ACB will not henceforth entertain/accept any property return of any employee in the shape of hard copy.

Accordingly, all the Members of Jammu and Kashmir Sheep Husbandry (Subordinate) Service are once again directed to register themselves on the PRS Portal and file their annual property returns for the year 2021 without fail.
