

All the Chairmen, District Level Departmental Promotion Committees are therefore directed to submit the proposal for approval alongwith documents as mentioned above to this office forthwith, enabling this office to accord approval forthwith. The above mentioned Chairmen, District Level Departmental Promotion Committees are further directed to issue placement orders in favour of the eligible Assistant Stockmen as Incharge Stock Assistants in own pay and grade pending clearance by the DPC with charge allowance admissible under rules. The date for the placement of eligible officials of each District will be the same so that this office is enable to maintain their seniority.
