Whereas, as reported by the District Sheep Husbandry Officer, Samba vide letter No. DSHOS/Tech/2020-21/998-1001 dated 19.11.2020 you have proceeded on 03 days Casual Leave w.e.f 10.11.2020 to 12.11.2020 by simply dispatching an application without seeking prior permission for leaving headquarter that too when model code of conduct due to DDC elections was in force; and

Whereas, you have been appointed in the department as Veterinary Assistant Surgeon vide Govt. order No. 59-ASH of 2019 dated 22.04.2019 under SRO-202 dated 30.06.2015 on probation and your services are under surveillance for declaring you as permanent in the Department; and

Whereas, District Sheep Husbandry Officer, Samba vide No. DSHOS/Esst/2020-21/1028-30 dated 27.11.2020 directed you to resume your duties; and

Whereas, this office vide No. DSHJ/Esstt-Gaz/F-278/2020-21/10841-43 dated 28.11.2020 followed by 1st notice No. DSHJ/Esstt-Gaz/F-278/2020-21/17581-85 dated 10.03.2021 and subsequent 2nd notice No. DSHJ/Esstt-Gaz/F-278/2021-22/1451-55 dated 17.04.2021 served upon you to resume your legitimate duties; and

Whereas, despite repeated notices and after the lapse of more than 06 months you did not report and failed to attend your legitimate duties; and

Whereas, your prolong and willful absence warrants action in terms of Article 128 of J&K Civil Services Regulations Volume-I which includes loss of appointment.

As such, you are once again directed to resume your duties within a week's time from the date of issue of this notice otherwise action as warranted under rules shall be initiated against you without any further notice.
