
Sir,

On the basis of reply submitted by this office vide No: DSHJ/Esstt-NG/F-259/2020-21/3004-3006 dated 15-06-2020 and conveyed the same by your good office to the complainant who in turn stated that he was satisfied with the reply but the complainant had mentioned in his reply dated 19-06-2020 that DSHO Rajouri has assigned the job pertaining to Junior Assistant to him besides holding the charge of planning section and requested for withdrawal of post of Junior Assistant from J&K Services Selection Board.

As far as assigning of job of the post of Junior Assistant to Sh. Gagan Shingar, Orderly is concerned, District Sheep Husbandry Officer, Rajouri has intimated this office vide his letter No: DSHOR/Esstt/2020-21/644 dated 13-06-2020 (copy enclosed) that he has been performing the job of Orderly. Out of two posts of Junior Assistant in the District, against one post Sh. Ram Saroop has been working as Junior Assistant in OPG and the other post is being referred to J&K Services Selection Board. The complainant deliberately dogged the Department by making irrelevant correspondence in Hon'ble Lt. Governor's Grievance Cell. The post once referred to J&K Services Selection Board can not be withdrawn.

As such, it is, earnestly requested to kindly dispose of the grievances of the complainant from your records as the complainant in question is again and again approaching your good office without any valid reasons and wasting the time of the Department.
