## TENDER NOTICE

For and on behalf of Governor, J&K state, sealed Tenders affixed with revenue stamps worth Rs.5/-are invited for Harvesting operations of Oats Fodder crop at various Farms of Jammu Division as per annexure "A" during 2015-16 on the following terms and conditions:-

## 1. TERMS AND CONDITIONS

- 1. Tender should be super scribed on the envelop as "Tender for Harvesting operation of Oats Fodder crop" addressed to the Chairman Provincial Level Purchase Committee Animal / Sheep Husbandry Deptt Jammu with full name & address of tenderer on the envelop. The tender documents can be purchased on payment of Rs 100/=in cash against proper GR which should be enclosed with tender along with CDR
- 2. The tender should reach in the office of Director, Sheep Husbandry Deptt. Jammu by or before 25-4-2015 during office hours up to 2 P.M. No tender shall be entertained after due date and time. In case this day happens to be a holiday, next working day shall be considered as last date for receipt of tenders. The Provincial Level Purchase Committee Animal / Sheep Husbandry Deptt Jammu shall open the tenders on the same day or any other date as convenient to the committee. The Tenderers or their representatives may if so desire can be present for witness at their own cost while opening the tenders by the committee.
- 3. Each tender must accompany GR of Rs.100/-non-refundable as tender fee and a C.D.R for the amount shown against each station of annexure "A" of any recognized / scheduled Bank of India ,pledged to the Account officer Sheep Husbandry Deptt Jammu. No Cheque/Demand Draft or cash will be accepted in any case. Previous C.D.R if any lying with the Deptt, shall not be considered for the tender. CDR of the successful tenderer shall be retained till completion of contract. No C.D.R shall be accepted after opening of tenders.
- 4. Provincial Level Purchase Committee Animal / Sheep Husbandry Deptt Jammu reserves the right to accept or reject any tender as a whole or part thereof without assigning any reasons.
- 5. Tenderer (s) shall quote their rates both in words and figures inclusive of all the taxes/charges on per quintal basis for each operation. The inputs required for baling operation whereever necessary i e HSD, Baling wire & baling machine etc shall be provided by the Deptt.
- 6. The successful tenderer (s) shall have to execute an agreement deed with the Deptt on non judicial stamped paper worth Rs. 20/=duly attested by notary within 15 days from the date of issuance of rate contract /work order . The terms and conditions of NIT shall form an integral part of the agreement. Successful tenderer shall have to deposit the security money pledged to the concerned DDO. in the shape of C.D.R of any schedule Bank equal to 5% of total value of the contract /work order.
