OBJECTIVES

1. Genetic up-gradation of livestock with improved/exotic germ plasm is the main activity associated with genetic up-gradation by natural service in small ruminants.
2. Development of Sheep sector by laying emphasis on increasing mutton production and at the same time stabilizing gains achieved in fine wool production through appropriate selection and breeding methods.
3. Safeguarding the uniqueness of genetic resources in Goat Sector by following the policy which is conducive to augmentation of quality Chevon through appropriate breeding technologies.
4. Prevention and Control of animal diseases through intensive vaccination of livestock with the ultimate goal to ensure a healthy society and production of disease free livestock products.
5. To ensure survival and propagation of minor livestock species and domestic farm species of specific importance to certain areas.
6. Development of Feed and Fodder resources in order to realize the true potential of the improved cross bred livestock.

1.	Treatment	Within One Day of the receipt of request by concerned Sheep Extension Centre/Veterinary Assistant Surgeon.
2.	Dosing/Dipping	Within One week of the receipt of request by concerned Sheep Extension Centre/Veterinary Assistant Surgeon.
3.	Vaccination	Within One week of the receipt of request by concerned Sheep Extension Centre/Veterinary Assistant Surgeon subject to availability of vaccine.
4.	Machine shearing	On first come first serve basis within 20 days of the receipt of request.
5.	Release of subsidy in case of ISDS units under Subsidy scheme	Within 15 days of verification of unit, submission of invoice and establishment of unit.
6.	Issue of Govt Rams/bucks for Breeding purpose	Within 10 days of the receipt of request and subject to availability of Rams/Bucks.
7.	Screening of Livestock, Examination of Faecal /Blood samples at Disease Investigation Laboratories of the concerned District/Division.	Within One week of the receipt of request by concerned Sheep Extension Centre/Veterinary Assistant Surgeon.
8.	Public Grievance Redressal	Within 30 days of the receipt of request.
