- 3. The Revised Operational Guidelines under "Integrated Sheep Development Scheme 2022-23" issued by Administrative Deptt; vide No. ASHF-PLG/18/2021-03 Dated: 17.05.2022 and further endorsed by this office letter No. DSHJ/P&S/2022-23/2689-99 dated 18.05.2021 and DSHJ/P&S/2022-23/6276-86 dated 23.08.2022 shall be strictly adhered/ followed.
- 4. The Animals purchased shall be free from any physical abnormalities and wool samples for the same shall be got tested from Fleece Testing Laboratory for various parameters.
- The procurement plans from conceiving the nature and quantity of public goods and services to be procured for preparation of tenders/ RFQs /EOIs to final award of the contract by the department shall be limited by an outermost cap of 60 days. Any spill over in timeline shall be allowed only under ordersof the competent authority with cogent reasons.
