The funds shall be utilized subject to the following conditions: -

1. That the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to Government of India's prescribed guidelines.
2. That the amount released shall be available for ongoing projects already sanctioned under RIDF- XXI of NABARD Loan.
3. No re-appropriation of funds shall be made without the approval of the competent authority and any laxity in terms of surrender of funds shall be viewed seriously and stern action with fixed responsibility against the defaulting officers shall be initiated under rules.
4. DDO shall complete all the codal formalities before presentation of the bills at the treasury.
5. The DDO shall ensure that the funds released are utilized prudently and judiciously and in no case they should book the expenditure just for the sake of spending.
6. That the Accounts Officer shall vouchsafe the utilization of funds as per codal procedure / Government of India's guidelines.
7. The DDO shall observe all the codal formalities including Accord of Administrative Approval and Technical Sanction while incurring expenditure, out of these funds.

8. The DDO shall send Utilization certificate of the funds released as early as possible and definitely well before 31.03.2023.
9. Treasury Officer shall not allow parking or drawal of funds in the Civil deposit without the prior concurrence of the Finance Department.
10. Treasury officer shall not entertain bills without complete classification under which funds have been authorized by the Finance department.
11. Monthly Physical and Financial Progress Report and cumulative expenditure and physical achievements of the funds so released shall be submitted to this Directorate by 2nd of every month.
