In supersession to this office Order no. 92- SHDJ of 2022 Dated: 09.05.2022 issued under endorsement No.DSHJ/P&S/UT Capex/2022-23/2257-60 Dated: 09.05.2022, sanction is hereby accorded to the grant of Administrative Approval amounting to Rs. 10.00 lacs (Rupees Ten Lacs only) for "Deep Drilling, Development and Stabilization of 200 mm dia Bore well/ Mini Tube well and providing, Fitting, Installation, Testing and Commissioning of Submersible Pump Set with 100mm dia GI Pipe alongwith allied electro-mechanical works" at Govt.
