- To probe the allegations of engaging private persons in place of permanent staff and the Work and Conduct of the officer and officials involved in malpractice including Stock Assistant trainees.
- To probe into irregularities in the Govt. livestock strength of the Farm.
- To probe assessment of working of staff on EPM Portal.
- To probe sale of manure, grass and fodder in SBF Balnoi.
- To pin point the role of the persons involved in the irregularities.
- Assessment of working of complainant and other staff also.

The enquiry committee shall submit its report along with suitable recommendations/necessary action within a period of 10 days to this Directorate.
