Subject: Misbehavior/use of unparliamentary Language by Dr. Arif Riyaz Saroori, Veterinary Assistant Surgeon (H.Q) Kishtwar.

ORDER NO. 294 -SHDJ of 2022
DATED 07 -12-2022

Whereas, District Sheep Husbandry Officer, Kishtwar vide communication No. DSHOK/Esstt/2022-23/783-84 dated 27.07.2022 have reported that Dr. Arif Riyaz Saroori, Veterinary Assistant Surgeon (H.Q) Kishtwar was directed to assess the losses of livestock occurred due to flash flood/cloudburst in Keshwan area of District Kishtwar and furnish report along with geo-tagged photographs for further submission to the Deputy Commissioner Kishtwar; and

Whereas, instead of complying the orders of his Controlling Officer, he misbehaved with District Sheep Husbandry Officer, Kishtwar and used unparliamentary language in front of staff members present in the office; and

Whereas, from the perusal of records available in this Directorate, it has been observed that numerous complaints has been received against Dr. Arif Riyaz Saroori, VAS in the past through the District Sheep Husbandry Officer, Kishtwar and Assistant Director, Govt. Sheep Breeding Farm, Thathri regarding dismal performance in achieving targets under KCC, leaving of office during working hours, negative/unprofessional attitude towards duties etc. He was warned to remain careful in future vide this Directorate's communication No. DSHJ/Tech/2019-20/5744-46 dated 01.08.2019 but he did not mend his ways and continued with his attitude; and

Whereas, this Directorate vide communication No. DSHJ-ESTT0GAZ/12/2021/5817-20 dated 08.08.2022 called an explanation of the officer and in response to that he has submitted reply vide No. VAS/K/2022-23/66-67 dated 17.08.2022 which has been examined in this Directorate and found non-convincing one; and

Whereas, the case of the officer was submitted to the Administrative Department of Animal/Sheep Husbandry & Fisheries J&K

vide communication No. DSHJ-ESTT0GAZ/12/2021/9037 dated 02.11.2022 for further necessary action in the matter; and


Whereas, Administrative Department vide communication No. ASHF-SH0GAZ/22/2022 dated 22.11.2022 has directed this Directorate to initiate action against the officer under Service Conduct Rules; and

Whereas, the case of the officer was examined in this Directorate and it has been decided to take lenient view in the matter and impose a penalty of Censure in terms of Rule 30(i) of J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

Now, therefore, in terms of Rule 30(i) of Jammu & Kashmir Civil Services (Classification, Control & Appeal) Rules, 1956, a penalty of censure is imposed upon Dr. Arif Riyaz Saroori, Veterinary Assistant Surgeon (H.Q) Kishtwar with strict warning to remain careful in future while performing his legitimate official duties and show full subordination to his superiors as required under rules/norms.
