Subject:- Transfer of Departmental land Rehian (samba) to Govt. Dairy Goat Farm Rajbagh

Order No. 3|| -SHDJ of 2023 Dated:- 03 -07-2023

Whereas, Assistant Director, Dairy Goat Farm Rajbagh Vide Communication no DGFR/F&F/23-24/246-47 dated 21-06-2023 has submitted proposal to this Directorate for allotment /Transfer of departmental land at Rehian (Samba) to Dairy Goat Farm Rajbagh for alternate grazing.

Whereas, in response to this office letter no DSHJ/F&F/2023-24/5351-56 dated 16-06-2023, Assistant Director Dairy Goat Farm Rajbagh along with Deputy Director (Feed & Fodder) of this Directorate visited the Land mentioned on the 19-06-2023 to assess the works to be taken for its land Development and its utilization as alternate grazing land.

Whereas, District Sheep Husbandry Officer Samba has 40 kanals of cultivable agricultural land along with newly constructed Hay shed and Feed store at Rehian (Samba).

Whereas, there is no livestock available with DSHO Samba and agriculture produce obtained from this land is either auctioned or shifted to Sheep Breeding Farm Billawar.

Whereas, Dairy Goat Farm has no other alternate Pasture for grazing of livestock. Moreover, Beetal breed of Goat maintained at Rajbagh is not suitable for highland migrations.

Whereas the stationary nature of this livestock and non -availability of alternate pasture land at Rajbagh has resulted in heavy parasitic infestations such as Haemonchosis, which results in production losses and huge mortality. The stain of Haemonchosis species at DGF Rajbagh is resistant to majority of drugs recommended for its treatment.

Whereas, the various experts consulted by AD DGF Rajbagh from time to time have suggested rotational grazing for its control and rest to the present pasture.

Whereas, Govt. land at Rehian can be used as alternate/rotational grazing and will provide rest to the existing pasture at Rajbagh .

Now therefore, keeping in view the above facts Sanction is hereby accorded to the transfer of 40 kanals of departmental Agricultural land Rehian from District Sheep Husbandry Officer Samba to Assistant Director, Govt. Dairy Goat Farm Rajbagh for its further utilization as alternate pasture for Livestock of Govt. DGF Rajbagh

All the agriculture operations in the said land shall be carried out by Assistant Director, Govt. Dairy Goat farm Rajbagh, henceforth whereas the watch and ward of land shall remain with the staff of DSHO samba.
