Subject: Resignation from Govt. services - Final Notice thereof.

Whereas, vide Govt. Order No. 156-JK(ASH) of 2021 dated 22.10.2021, you have been appointed as Class-IV in Pay Level-SL1 (14800-47100) in District Cadre Rajouri under RBA category in Sheep Husbandry Department Jammu and joined in Directorate of Sheep Husbandry Jammu on 02.11.2021; and

Whereas, vide this office Order No. 201-SHDJ of 2021 dated 30.11.2021 issued under endorsement No. DSHJ/Esstt-NG/F-121/2021-22/15605-13 dated 30.11.2021, you have been posted/adjusted as Chowkidar in Sheep & Wool Development Office Kalakote; and

Whereas, as reported by Sheep & Wool Development Officer, Kalakote, you joined in his office on 01.12.2021 afternoon and went back to your home to carry your luggage including bedding to reside in the campus and to properly perform the duties of Chowkidar but you didn't report back; and

Whereas, on 14.12.2021, you handed over your resignation in the office of Sheep & Wool Development Officer, Kalakote citing reasons that you cannot perform the duties of Chowkidar and thus resigning from the service; and

Whereas, Sheep & Wool Development Officer, Kalakote vide communication No. SDOK/Esstt/2021-22/1044-48 dated 15.12.2021 followed by 1st Notice No. SDOK/Esstt/2021-22/1057-61 dated 23.12.2021 and subsequently 2nd Notice No. SDOK/Esstt/2021-22/1123-27 dated 08.01.2022 served upon you to resume your legitimate duties; and


Whereas, you were provided enough opportunities to resume your duties by the Drawing & Disbursing Officer concerned, which you failed; and

Whereas, District Sheep Husbandry Officer, Rajouri vide communication No. DSHOR/Esstt/2021-22/4569 dated 25.01.2022 submitted your resignation case to this Directorate for further necessary action; and

Whereas, you were appointed on temporary basis and were on probation for a period of 02 years under the provisions of S.O 192 dated 17.06.2020.

Now, before action under relevant Articles of J&K Civil Services Rules 1956 for cancellation of probation and your disengagement from Govt. services from the post of Chowkidar, a final opportunity is hereby given to you through the medium of this notice to resume your duties within a period of 07 days from the date of issuance of this notice failing which it shall be presumed that you have nothing to say in your defense and action as warranted under rules shall be initiated against you without any further notice.
