Whereas, Mr. Mehtaab Tanveer S/O Tanveer Hussain Shah R/O Saimsmith Tehsil Thanamandi District Rajouri was appointed vide Govt. Order No. 156-JK(ASH) of 2021 dated 22.10.2021 as Class-IV in Pay Level-SL1 (14800-47100) in District Cadre Rajouri under RBA category in Sheep Husbandry Department Jammu and joined in Directorate of Sheep Husbandry Jammu on 02.11.2021; and

Whereas, this Directorate vide No. DSHJ-ESTTONG/28/2021/3816-21 dated 13.06.2022 has issued final notice to Mr. Mehtab Tanveer (Chowkidar) S/O Tanveer Hussain Shah R/O Saimsmith Tehsil Thanamandi District Rajouri to resume his duties within a period of 07 days failing which it shall be presumed that he has nothing to say in his defense and action as warranted under rules shall be initiated against him without any further notice and the same was delivered to the official at his home address Village Saimsmith Tehsil Thanamandi District Rajouri under proper receipt by Sheep & Wool Development Officer, Kalakote on 15.06.2022 in presence of his father; and

Whereas, as reported by Sheep & Wool Development Officer, Kalakote vide communication No. SDOK/Esstt/2022-23/621-23 dated 03.09.2022, Mr. Mehtab Tanveer has not joined in his office; and


Whereas, the above official was appointed on temporary basis and were on probation for a period of 02 years.
